

## UCF's Gabor A&P Excellence Award

You are invited to participate in the University of Central Florida's Excellence Award nominations, sponsored by The Gabor Agency. The purpose of this awards program is to recognize, appreciate and celebrate outstanding job performance of selected A&P employees. Individuals or groups who have first-hand experience with an employee's outstanding job performance are invited to make nominations. The candidate chosen for this award will be announced at the Annual Employee Awards Program in August 2016, and the employee will receive a check for \$2,500. All nominations must be received in Human Resources no later than **May 20, 2016**.

### UCF Excellence Award Eligibility Criteria (will be verified by HR):

1. The nominee must be employed in an established non-unit A&P position.
2. The nominee must have a minimum of one (1) year of continuous university service.
3. The nominee's contributions should exceed those that are expected of the employee during the normal course of performing his/her duties.
4. The nominee should demonstrate the high standards and excellence expressed in the UCF Mission, Vision and Goals. We encourage all nominators to keep the Mission, Vision, and Goals in mind when identifying individuals to be considered for this award.
5. Nominees may receive this award a maximum of one (1) time every five (5) years.
