



# 2018 Gabor A&P Excellence Award Nominations

Nominations for UCF's Gabor A&P Excellence Award are now being accepted. Sponsored by The Gabor Agency, the purpose of this award program is to recognize, appreciate, and celebrate outstanding job performance of selected A&P employees over the course of the 2017-2018 fiscal year. Individuals or groups who have first-hand experience with an employee's outstanding job performance are invited to submit nominations. Announced at the Annual Employee Awards Program in October 2018, the candidate chosen for this award will receive a check for \$2,500. All nominations must be received in Human Resources no later than *5:00 p.m., August 3, 2018.* 

# GABOR A&P EXCELLENCE AWARD ELIGIBILITY CRITERIA (will be verified by HR)

- 1. The nominee must be employed in an established non-unit A&P position.
- 2. The nominee must have a minimum of one year of continuous university service before being nominated.
- 3. Nominees may receive this award a maximum of one time every five years.
- 4. The nominee's contributions should exceed those expected of the employee during the normal course of performing their duties. (Position descriptions will be available to the selection committee for review.)
- 5. The nominee should demonstrate the high standards and excellence expressed in UCF's Values and Creed, and the UCF Collective Impact Strategic Plan. High-level excerpts from the Plan are below; we encourage all nominators to keep the Plan in mind when considering nominees for this award. (Please refer to the Plan for complete details.)
