## Dear FRS Member:

To help you better prepare for retirement, the Florida Retirement System (FRS) provides free access to financial planners, retirement counselors, and online services available through our toll-free MyFRS Financial Guidance Line and MyFRS.com website. I encourage you to take advantage of these free resources to:

- **Get Your Retirement Income forecast.** Unbiased Ernst & Young financial planners can help you understand, coordinate, and create a retirement plan for all of your sources of retirement income: Social Security benefits, FRS benefits, and personal savings. Division of Retirement counselors can answer all of your Pension Plan questions.
- Investigate your 2nd Election option, if available. You may or may not be better off switching FRS plans. If your personal situation changes, the Second Election Choice Service can help you re-evaluate your current plan against the other to see which one works best for you, given your new circumstances.
- **Get a debt management checkup** to understand what debts should be paid-off or consolidated before, or during retirement. In these tough financial times, having a plan to rid yourself of debt is one of the best things you can do for yourself and your family.
- Get the most out of your employer's deferred compensation (457, 403(b), or 401(k)) supplemental retirement plan. If you do not participate in a plan, consider joining. And if you do participate, consider increasing your contributions to increase your tax-deferred retirement nest egg. If you already contribute the maximum, you may be eligible to increase your monthly contributions under the Federal catch-up provisions.
- **Get Pension Plan estimates and a DROP projection** (applicable to FRS Pension Plan members only) so you can understand your future projected retirement benefits.
- Attend a free Financial Planning Workshop in your area. Topics include: Using the FRS to Plan for Your Retirement, Nearing Retirement in the FRS, Estate Planning, Cash and Debt Management, Education Planning, and Insurance Planning. Register online at <a href="MyFRS.com">MyFRS.com</a>.

  Young financial planner. Or you can log in to <a href="MyFRS.com">MyFRS.com</a> and access the service yourself.
  - What can the ADVISOR SERVICE do for me?
     The free online ADVISOR SERVICE creates a picture of your current financial situation and helps you answer the following questions:
    - ✓ Will I have enough money to retire?
    - ✓ How do I invest my retirement savings?
    - ✓ How do I stay on track to achieve my goals?

### **Both Pension Plan and Investment Plan members can:**

- Receive a total retirement income forecast that includes your FRS benefits, a projected Social Security benefit, and any outside assets you may add.
- Receive an estimate of the likelihood of meeting your retirement income goal.
- Get investment guidance on the portfolio mix of the investments in <u>all</u> of your taxable and tax-deferred retirement accounts by upgrading the service for a nominal yearly fee (click on "Upgrade" after accessing the ADVISOR SERVICE).

 Get free investment guidance on the portfolio mix of the investments in one of your non-FRS tax-deferred accounts, such as your 457 or 403(b) savings account.  Get free investment guidance on the portfolio mix of the investments in your FRS Investment Plan account.
