

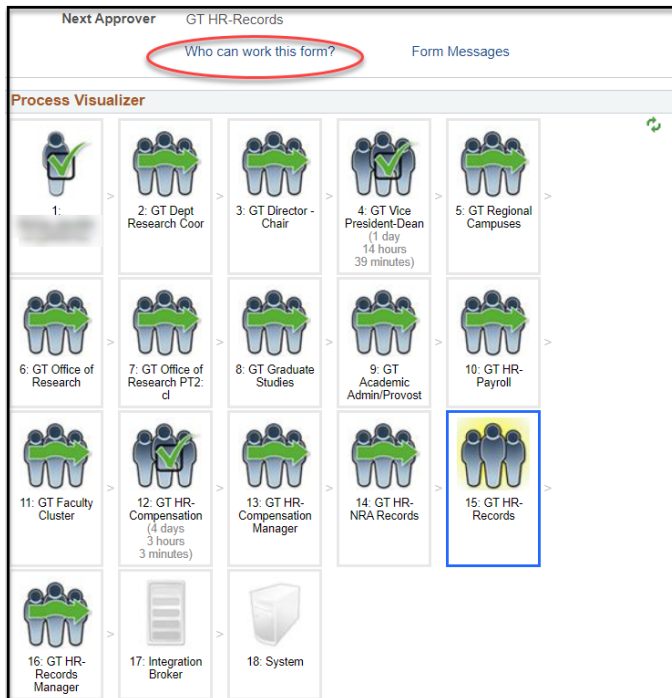
Tracking ePAFs

The View an ePAF is a great tool to use in tracking the progress of an ePAF that was submitted within the 30-day period prior to the current date. The original form can be easily and quickly retrieved to determine exactly where it is in the electronic approval process, who can approve it, and where it will be going next.

- Navigate to ePAF Home Page (Human Capital Management-Main Menu-Department Self Service-ePAF Home Page)
- Click on View an ePAF (for ePAFs submitted over 30 days ago, select Lookup an Archived ePAF)
- Click on the type of ePAF you want to view
- Enter the ePAF number or Employee ID number
- Scroll to the bottom and click the “next” button



This screen shows all the stages and who can approve for said department



-If there is a green check it has already gone thru this stage

-The green horizontal arrow means that an approver is not required in this stage for this particular ePAF

-The blue box indicates where the ePAF is now

-The grayed-out stages(s) are department(s) that still need to approve

-Records is the last approver. The integration broker is always on unless we are paused (payroll processing or loading information)

-Once the last box “system” is checked that means the ePAF has posted to job data

This screen also contains a log of who approved/submitted for each stage
